# ALUMNI AND STUDENT NEWS



**DR. URLETTE REYES** (Cohort 7) is a science instructor at King Drew Magnet High School of Medicine & Science. This summer a small group, led by Urlette and Urban Reves, conducted a grassroots sea grass monitoring and identification project in the waters of Belize City, Belize. Three sites were studied, Manatee Bar, Jounce Caye and Swallow Caye. The purpose of this project was to determine water quality, identify the species present, obtain base line data on the abundance of sea grass in these areas, as well as the feasibility of current sea grass protocols for this area. The team discovered two prominent species of sea grass within these areas Thalassia testudinum (common name Turtle grass) and what appeared to be Syringodium filiforme (common name Manatee grass). Manatee Bar and Swallow Caye are areas known to be within the migration path of the West Indian Manatee, a species currently on the endangered species list (Glenn, 2006; US Fish and Wildlife Service, 2013). making the sea grass in this area an important commodity for their survival. The team is now exploring the possibility of using computer based technology such as probes or ROV's to assist in the continued monitoring of these areas. Urlette's exciting field experience will undoubtedly

enhance her science classes at King Drew.

sentations, generative discussion, and professional growth. The majority of Clark Scholars go on to become professors at major research institutions around the world. This year's seminar will be held in the spring at the beginning of the AERA meeting in Philadelphia (tentatively scheduled for April 2-3, 2014). Nominations are due November 5th, 2013.

Nominees should be outstanding doctoral students in educational leadership, administration, and/or policy, seeking careers in research. Nominees must have substantially completed their courses and must have formulated a dissertation proposal. Students who have already started or completed their dissertations are unlikely to gain as much from the seminar as students who are in the early stages of formulating their research. Nominations of students from underrepresented groups are strongly encouraged.

Student proposals are blind reviewed by three prominent scholars. Invitations will be issued to 40 doctoral students, with competition based on the quality of the student's proposal and their perceived capacity to gain from and contribute to the seminar.

Each university may nominate up to two students. Nominations must be accompanied by a student research proposal. This year, all materials will be submitted online, see directions for nomination materials and an overview of the Clark Seminar process can be found at the following urls:
